

CONDITIONS OF BOOKING

DEPOSITS ARE FOR ADMINISTRATION COSTS AND ARE NOT REFUNDABLE

WE REGRET NO DOGS ACCEPTED. (Except Guide Dogs)

Pitches will only be reserved if a deposit of £20 a pitch has been paid and a confirmation given

The balance for all booked nights to be paid on arrival. In the case of ferry bookings the balance is required 42 days before arrival so that the tickets may be prepared.

Once full payment has been made Landguard Camping is not obliged to give refunds and you are advised to consider insurance.

Bookings are only accepted from family parties and mixed couples.

The person whose signature appears on the booking form warrants that he or she is over 18 years old, is one of the party and that it will not exceed the number stated on the booking form.

A charge will be made for cheques represented by the bank.

Speed limit on the park is 5 MPH, please comply with it.

Pup tents, Gazebos etc will only be permitted if space allows them to conform to fire regulations.

For the comfort of all our clients we regret that generators are not permitted.

Pitches are available from 12noon on arrival and must be vacated on the day of departure by 11.00 am

In the event of non-arrival on the specified date the management reserve the right to re-let the pitch the following day.

Landguard Camping reserve the right to charge an administration fee for undue alterations to ferry bookings already made.

The management will not be held responsible to any persons listed on the reservation form for any loss or damage to property or personal injury. All bookings are accepted entirely at the management's discretion and they reserve the right to refuse or terminate the stay of person or persons creating a nuisance to others.

No loud musical instruments or radios at anytime. Campers are required to be quiet between 11.00pm & 7.00am.

Where clients have been advised of their pitch the management reserve the right to reallocate alternative pitches at their discretion.

Force Majeure – Landguard Camping shall not be held liable for non – performance of any of its obligations under this agreement if such non – performance shall occur as a result of circumstances beyond their control which shall include (but not be limited to) industrial dispute, fire, flood, riots, adverse weather conditions, civil dispute, epidemics, health risks or such similar events.
